

EXPRESSION OF INTEREST (EOI)
IRRIGATION DEPARTMENT, GOVERNMENT OF PUNJAB
FEASIBILITY STUDY ON HILL TORRENTS AND FLOOD MITIGATION IN
MIANWALI DISTRICT

Punjab Irrigation Department, Lahore intends to hire the services of engineering consulting firms for the preparation of detailed feasibility study on "Feasibility Study on Hill Torrents and Flood Mitigation in Mianwali District". An approximate amount of Rs. 50 Million is to be expended for preparation of detailed feasibility study report for this consultancy assignment.

Following broad based services are required: -

- a) Prepare feasibility level designs and for that purpose carry out surveys, site investigations, analyses, and prepare technical notes and designs reports;
- b) develop hydrologic and hydraulic modeling of the rainfall runoff patterns, flash flooding, storage adequacy, irrigation canals design with assessment of the impact of climate change;
- c) In particular consultants will carry out technical, environmental and social impact analysis of materials to be disposed off that may be generated during the construction activities and prepare detailed design for safe disposal of such materials;
- d) prepare feasibility level design for the proposed remedial works. Drawings will be prepared to the extent that adequate cost estimates will be possible;
- e) review the works required for environmental management plan during construction and long term operation and include them in the designs to the extent possible and in the cost estimates.
- f) Prepare draft PC-I based on the feasibility studies.

Interested consultant firms are invited to indicate their interest for providing the services by providing the following information:- :

- a) Name, address, telephone, fax numbers and e-mail address of consultants;
- b) Ownership and Organizational Structure of the consultant;
- c) Registered with PEC and other government agencies;
- d) Copy of registration with SECP or Registrar of Firms;
- e) Financial Statement Summary for the past five (05) years / working capital;
- f) Certificate of Nation Tax Number with Federal Board of Revenue;
- g) List of major (similar) assignments under-taken over the past 07 years;
- h) List of owned resources / machinery;
- i) Names and CVs of Principal Staff;
- j) Certificate / affidavit that firm is not blacklisted by any government / autonomous body.

The deadline for receipt of applications is **22-09-2014**. A shortlist shall be finalized from the aforementioned submission. Only the firms with demonstrated experience in similar assignments, and requisite resources will be considered and notified for further participation in the tendering process. The procuring agency has the right to accept or reject all applications by assigning cogent reasons thereof, if requested.
